Dear Shareholder.

1. Introduction

I am pleased to be writing to you with details of the Annual General Meeting ("AGM") for Eleco Public Limited Company (the "Company") which we are holding at our NOMAD's offices, Cavendish, One Bartholomew Close, London, EC1A 7BL on Tuesday 4 June 2024 at 11:00 a.m. (BST). The formal notice of AGM is set out on pages 5 to 8 of this document. Your attention is drawn to the recommendations of the Board as set out in paragraph 4 of this letter.

2. Explanatory notes to the notice of the AGM

The following notes explain the proposed resolutions. Resolutions 1 to 11 are proposed as Ordinary resolutions. For each of the Ordinary resolutions to be passed, more than half of the votes cast must be in favour of each resolution. Resolutions 12 and 13 are proposed as Special resolutions. For each of the Special resolutions to be passed, at least three quarters of the votes cast must be in favour of each Special resolution.

Resolution 1 - Annual report and accounts

The directors must present the audited annual accounts and the directors' and auditors' report for the financial year ended 31 December 2023.

Resolutions 2 and 3 - Re-appointment and remuneration of auditors

The Company must appoint auditors at each annual general meeting at which accounts are presented to shareholders to hold office until the conclusion of the next such meeting. As set out in the Annual Report and Accounts on page 40, the Audit and Risk Committee has assessed the effectiveness, independence, and objectivity of RSM UK Audit LLP and recommends their re-appointment as the Company's auditors.

In accordance with normal practice, Resolution 3 seeks authority for the Company's directors to fix the auditor's remuneration.

Resolutions 4 - Final Dividend

If resolution 4 is approved by shareholders, the final dividend for the year ended 31 December 2023 of 0.55 pence per Ordinary share will be paid on 28 June 2024 to shareholders whose names appear on the register of members at close of business on 14 June 2024 (the "Final Dividend").

Resolutions 5 to 10 - Re-appointment of directors

The Company's articles of association require one third of the directors to retire by rotation each year. Those directors are then eligible for re-election by shareholders. No director may serve for more than three years without being re-elected by shareholders.

The Board is committed to corporate governance best practice and, in accordance with this, has adopted the policy that all the directors of the Company will stand for re-election at the AGM. This is in line with the recently updated QCA Code.

The biographical details of all directors can be found on the Company's website at https://eleco.com/governance/board.

The Board believes that the balance and makeup of the Board is appropriate for the Company and aligns with corporate governance good practice. The Nomination Committee reviews on an annual basis the balance and composition of the Board, including the independence of all Non-Executive Directors. The Board believes that each Director continues to make valuable contributions to the Board and has sufficient time to meet the responsibilities of the role.

Resolutions 11 to 13 - Directors' authority to allot, disapply pre-emption rights and purchase own shares

Resolutions 11, 12 and 13 relate to directors' authority to allot shares, disapply statutory pre-emption rights and allow the Company to make market purchases of its own shares. It is important for shareholders to note that the Company requires such authorities from its shareholders to be able to raise funds which may be essential for its operation. The Board has carefully reviewed the authorities requested and taken external advice on the level of these authorities. They have concluded that they are in line with best practice including share capital management guidelines issued by the Investment Association (the "Guidelines") as noted below. Companies whose shares are admitted to trading on the Alternative Investment Market ("AIM") are encouraged to adopt the Guidelines, although they are not binding on companies listed on AIM and many companies listed on AIM choose to request authorities in excess of those recommended under the Guidelines.

Resolution 11 - Directors' authority to allot

The routine renewal of this authority is to provide flexibility in managing the Company's capital resources, however the directors have no present intention to exercise the authority and would consult with shareholders prior to any use of the authority.

Following a recommendation by the Rights Issue Review Group to the Chancellor, the ceiling on directors' authority to allot shares was recently increased from one-third to two-thirds. Despite this, the Board has concluded that a ceiling amount of 15% the Company's issued share capital remains appropriate for the Company. This is considerably lower than that permitted by the Guidelines but the Board believes that this is sufficient for the Company's needs at this time and helps to protect shareholders from unexpected dilution.

Paragraph 11.1 of Resolution 11 would give the directors the authority to allot shares in the Company and grant rights to subscribe for or convert any security into shares in the Company up to an aggregate nominal value of £124,811.10. This represents approximately 15% of the Ordinary share capital of the Company in issue as at 30 April 2024 (being the latest practicable date prior to the publication of this notice).

The directors' authority will expire (unless previously revoked by the Company) on the earlier of 30 June 2025 and the conclusion of the next annual general meeting.

Resolution 12 - Statutory pre-emption rights

Under company law, when new shares are allotted for cash, they must generally first be offered to existing shareholders pro rata to their holdings. A special resolution to disapply pre-emption rights should comply with the provisions of the Pre-emption Group's current Statement of Principles. In November 2022, The Pre-emption Group updated the Statement of Principles to recommend an increased authority for the general disapplication of pre-emption rights from 5% up to 10% of the issued share capital.

The Board has considered the new guidance and concluded that a limit of 5% remains appropriate for the Company. This special resolution gives the directors authority for the period ending 30 June 2025 or, if earlier, the date of the next AGM, to: (a) allot shares of the Company for cash in connection with a pre-emptive offer; and (b) otherwise allot shares of the Company for cash up to an aggregate nominal value of £41,603.70 (representing in accordance with institutional investor guidelines, approximately 5% of the total Ordinary share capital in issue as at 30 April 2024 (being the latest practicable date prior to the publication of this notice) as if the statutory pre-emption rights under the Companies Act 2006 law did not apply. Again, the board believes that adopting a lower limit is in the best interests of shareholders.

Resolution 13 - Authority for market purchase of own shares

Resolution 13 grants the Company authority to make limited market purchases of the Company's Ordinary shares. While the Board have no current intention to exercise this authority, it is considered prudent for the Directors to have flexibility to do so if they believe it would be in shareholders' interests as a whole. The Guidelines comment that a general authority to purchase up to 10% of the existing shares in issue of a Company is standard practice. The Board has therefore requested authority to repurchase its own shares up to the amount of 8,320,740 of the Ordinary shares in issue representing 10% of the issued share capital as at 30 April 2024 (being the latest practicable date prior to publication of this notice) and sets out the minimum and maximum prices that can be paid, exclusive of expenses. The authority conferred by this resolution will expire at the conclusion of the Company's next AGM or 30 June 2025 from the passing of this resolution, whichever is the earlier.

3. Dividend

As set out in the Annual Report and Accounts on page 04, due to the Company's strong cash position the Board is recommending a Final Dividend for the financial year ended 31 December 2023 of £452,648 equating to a dividend per share of 0.55 pence. This dividend is expected to be paid on 28 June 2024 to all shareholders appearing on the register of members as of 14 June 2024, with an ex-dividend date of 13 June 2024.

4. Recommendations

The Board considers that all the resolutions to be put to the meeting are in the best interests of the Company and its shareholders as a whole.

Your Board will be voting in favour of all resolutions and unanimously recommends that you do so as well.

5. Action to be taken by shareholders

The resolutions are subject to shareholder approval. A notice convening the AGM is set out on pages 5 to 8 of this document.

A form of proxy for the AGM is enclosed with this document and you are requested to complete and post the form of proxy to the Company's registrars as soon as possible or submit your vote via CREST or via www.sharegateway.co.uk if applicable. The completion and return of a form of proxy will not prevent you from attending the AGM in person, speaking and voting if you wish to do so.
